Pursuant to item II of the Decision on Determining of the Public Telecommunications Operator of Fixed Telephony Network Services with Significant Market Power, reached by the Managing Board of the Republic Telecommunication Agency, number 1-Kab-6-10/06-1 of 24<sup>th</sup> March 2006, Articles 12 and 18, paragraph 1, item 7 of the Statutes of the Republic Telecommunication Agency ("Official Gazette of the RoS", no. 78/05) and on the request of the Telecommunications undertaking "Telekom Srbija", Joint Stock Co., number 111838/1 of 9<sup>th</sup> October 2006, the Managing Board of the Republic Telecommunication Agency, in its session held on 20<sup>th</sup> October 2006, adopted the following

### **DECISION**

1. Telecommunications undertaking "Telekom Srbija", Joint Stock Co., is granted approval to, starting with 1<sup>st</sup> November 2006, increase the subscription fee for telephone extension for residential and business users to the amount of 74,75 dinars (seventy four and 75/100 dinars), VAT excluded.
2. Telecommunications undertaking "Telekom Srbija", Joint Stock Co., is obliged to inform its users, in adequate way, of the fee increase referred to in item 1. of this Decision.
3. This Decision comes into force on the day following the day it has been adopted and will be applied as from 1<sup>st</sup> November 2006.
4. This Decision will be published on the website of the Republic Telecommunication Agency.

### **Explanation**

Telecommunications undertaking "Telekom Srbija", Joint Stock Co. submitted to the Republic Telecommunication Agency request to be granted approval to increase the telephone subscription fee, under number 111838/1, of 9<sup>th</sup> October 2006.

In accordance with its powers, the Republic Telecommunication Agency has the authority to set tariffs within a special tariff regime for those telecommunication

operators providing public fixed telephone network services, which have significant market power.

In this regard, the Managing Board of the Republic Telecommunication Agency, having considered the facts stated in the request of “Telekom Srbija”, Joint Stock Co., in particular the comparative analysis of the subscription fees in the region, adopted the decision regarding the subscription fee increase for residential and business users to the amount of 74,75 dinars, VAT excluded, which is, inter alia, comprised in the chapter III item 4. of the Basis for Developing the Strategy for the Telecommunications Sector, adopted by the Government of the RoS.

In accordance with the above stated reasons, the Decision was adopted as stated in the order above.

**Right to appeal:** This Decision is final, and against it administrative procedure can be taken before the Supreme Court of Serbia.
