

Pursuant to Article 84, paragraph 4 of the Telecommunication Law (*Official Gazette of RS*, nos. 44/03 and 36/06), and Article 18, paragraph 1, item (11) of the Statute of the Republic Telecommunication Agency (*Official Gazette of RS*, no. 78/05),

The Republic Telecommunication Agency Managing Board, on its session held on February 20, 2009, adopted the following

DECISION ON THE AMOUNT OF THE ANNUAL FEE FOR USING THE ASSIGNED NUMBERS AND ADDRESSES FROM THE NUMBERING PLAN

I General provisions

Article 1

The amount of the annual fee for using the assigned numbers and addresses from the Numbering Plan payable by a public telecommunications operator is hereby set out.

Article 2

Public telecommunications operator shall pay an annual fee for using the assigned numbers calculated on the grounds of the following values:

- 1) Parameter „*A*“, determined by the type of public telecommunication service, as a criterion for setting the annual fee as follows:
 - For public fixed telecommunications network services – *A_f*;
 - For public mobile telecommunications network services – *A_m*;
- 2) Parameter „*B*“, determined by the number of inhabitants in the area where the assigned number is to be used, according to the official data of the authority in charge of statistic affairs, as a criterion for setting the annual fee as follows:
 - For public fixed telecommunications network services – *B_f*;
- 3) Parameter „*C*“ determined by whether there is a particular purpose for which the assigned number and/or numbering (internal numbering, addressing in telecommunications networks, commercial exploitation of the assigned number, etc.) is used, as a criterion for setting the annual fee.

II Annual fee for the usage of assigned numbers

Article 3

Annual fee for the usage of assigned numbers in public fixed telecommunications network shall be calculated according to the following formula:

$$N = A_f \times (1 + B_f) \times D$$

where:

N – amount of the annual fee;

A_f – parameter whose value amounts to 6.00;

B_f - ratio of inhabitants of the Numbering Plan network group to the total population;

D – number of assigned numbers.

Article 4

Annual fee for the usage of assigned numbers in public mobile telecommunications network shall be calculated according to the following formula:

$$N = A_m \times D$$

where:

N - amount of the annual fee;

A_m - parameter whose value amounts to 12.60;

D – number of the numbers assigned to end-users.

Article 5

Annual fee for the usage of an individually assigned number for the provision of non-commercial services of public interest shall be calculated according to the following formula:

$$N = K \times C$$

where:

N – amount of annual fee;

K - coefficient amounting to:

- 1 for a four-digit number ;
- 20 for a three-digit number;

- 40 for a two-digit number;

C – parameter whose value is 25,000.

Annual fee for usage of individually assigned numbers for emergency services shall not be charged.

Article 6

Annual fee for the usage of the following assigned non-geographic numbers for high-priority services shall be calculated according to the following formula:

$$N = C \times D$$

where:

N - amount of annual fee;

C - parameter whose value is 25,000 and

D - number of numbers assigned to end-users.

Annual fee for the usage of service code 42 for high-priority services shall amount to 2,000,000.00 dinars.

Annual fee for usage of assigned numbers for high-priority services used for humanitarian purposes shall not be charged.

Article 7

Annual fee for the usage of assigned non-geographic numbers for low-priority services shall be calculated according to the following formula:

$$N = C/10 \times D$$

where:

N - amount of annual fee;

C - parameter whose value is 25,000;

D - number of numbers assigned to end-users.

Article 8

Annual fee for usage of single assigned codes - addresses shall be set as follows:

III Transitional and final provisions

Article 9

Upon the entrance into force of this Decision, the Republic Telecommunication Agency shall set an annual fee for the usage of the assigned numbers payable by the operators who have been granted the usage of numbers from the Numbering Plan in the primary assignment.

On the day this Decision enters into force the Decision on the amount of the annual fee for using the assigned numbers from the Numbering Plan (*Official Gazette of RS*, no. 3/09) shall cease to be valid.

Article 10

This Decision shall enter into force on the eighth day following its publication in the *Official Gazette of the Republic of Serbia*.
