


INSTRUCTIONS ON THE USAGE OF R&TT EQUIPMENT CERTIFICATE OF CONFORMITY, EXCERPT FROM THE REGISTER OF THE ISSUED R&TT EQUIPMENT CERTIFICATES OF CONFORMITY AND CONFORMITY MARK

Conformity assessment is a procedure where, by issuing a Certificate of Conformity and/or Excerpt from the Register of the Issued Certificates of Conformity, the conformity of a product with a standard, technical and other regulation or technical specification is certified.

Conformity assessment –for radio equipment and telecommunications terminal equipment (hereinafter: R&TT equipment) shall be performed by the Republic Agency for Electronic Communications (hereinafter: Agency), as the nominated body for R&TT equipment conformity assessment according to the Rulebook on Radio Equipment and Telecommunications Terminal Equipment (*Official Gazette of RS*, no. 11/12, hereinafter: Rulebook on R&TT equipment).

R&TT equipment conforming with the essential requirements referred to in Arts. 4 and 5 of the Rulebook on R&TT equipment, shall be marked with the conformity mark pursuant to the Regulation on the manner of performing the conformity assessment and the shape, design and content of the conformity mark (*Official Gazette of RS*, no. 98/09).

The Serbian conformity mark shall contain three capital letters "A" connected in such a manner as to form an equilateral triangle (3A), of the appearance and content as presented in the following drawing :



The height of the mark shall be at least 5mm. The Serbian mark shall be accompanied by the unique identification number of the Agency as the nominated body, from the register of nominated, i.e. authorized bodies for conformity assessment, as well as by the two last digits of the year of the issuance of the Certificate of Conformity or the Excerpt from the Register of the Issued Certificates of Conformity, in case the conformity assessment has been performed by the Agency.

The unique identification number of the Agency as a nominated body shall be II 011.

The Serbian mark shall be affixed to the product by the manufacturer or their representative, or the importer in case the manufacturer and the representative are not registered in the territory of the Republic of Serbia, in a visible place so as to provide legibility, visibility and prevent erasing, preferably on the same label with other marks. The mark should not be affixed to the parts of the product removed during service and repair.

Any other marks, symbols, labels and other marks may be affixed to R&TT equipment provided that the visibility, legibility or the meaning of the conformity mark is not thereby reduced.

In case R&TT equipment is subject to other regulations regulating other matters, which also involve conformity marking, the affixed conformity mark shall mean that the equipment conforms with the requirements of these other regulations as well.

The holder of the Certificate of Conformity or Excerpt from the Register of the Issued Certificates of Conformity must not use the Certificate of Conformity or Excerpt from the

Register of the Issued Certificates of Conformity in a way that might cast doubt on the reputation of the Agency, nor provide information regarding the conformity of the product such as to disregard these Instructions.

The holder of the Certificate of Conformity holder shall be required to inform the Agency in writing of any change in the conforming product. The Agency shall be required to inform in writing the holder of the Certificate of Conformity holder whether the issued Certificate of Conformity remains in force or additional assessment is needed for the Certificate of Conformity to be valid.

The holder of the Certificate of Conformity or Excerpt from the Register of the Issued Certificates of Conformity must not use the Certificate of Conformity or Excerpt from the Register of the Issued Certificates of Conformity nor the Serbian conformity mark after they cease to be valid.

The Agency shall temporarily or permanently revoke the Certificate of Conformity or Excerpt from the Register of the Issued Certificates of Conformity should it be found in any way that the holder of the Certificate of Conformity or Excerpt from the Register of the Issued Certificates of Conformity does not fulfil the conditions based upon which the former or the latter have been issued.

The holder of the Certificate of Conformity or Excerpt from the Register of the Issued Certificates of Conformity shall be required to prevent the placing on the market of all products marked with the Serbian conformity mark, during the temporary or upon the permanent revocation thereof.

Complaint or appeal lodged by the holder of the Certificate of Conformity or Excerpt from the Register of the Issued Certificates of Conformity regarding the decision on the temporary or permanent revocation thereof shall not postpone the execution of the decision.
