

Pursuant to paragraph 2 of Article 19, and in regard to paragraph 5 of Article 36 and paragraph 8 of Article 38 of the Telecommunications Law (*Official Gazette of the Republic of Serbia* number 44/03 and 36/06) and pursuant to item 11 of Article 18 of the Statutes of the Republic Telecommunication Agency (*Official Gazette of the Republic of Serbia* number 78/05),

The Managing Board of the Republic Telecommunication Agency in its session held on 5th May 2006, adopted the

RULES ON FEES AND COSTS FOR LICENSE AND AUTHORIZATION ISSUANCE

Article 1

These Rules define the amount of the periodic annual license fee and the amount of the authorization fee, and also, the amount of costs of issuance and/or extension of period for which the license or authorization has been issued.

Article 2

The amount of periodic annual license fee is determined according to the type of telecommunication service, and the amounts are as follows:

No.	Type of telecommunications services	Amount of fee
1)	Public mobile telecommunications networks, in part or wholly, realized via public mobile telecommunication network on determined radio frequencies GSM/GSM 1800 and UMTS/IMT-2000 license	-0.9% of total income realized in the business year for which the fee is paid; -the advance for periodic annual fee for the first year is 70 million dinars, on annual level
2)	Public voice services publicly offered on commercial basis real-time voice transmission and voice switching services between termination points of public fixed telecommunication network	-0.1% of total income realized in the business year for which the fee is paid; -the advance for periodic annual fee for the first year is 20,000.00 dinars per each 1000 subscribers, on annual level
3)	Public data transmission services, offered to users via public data transfer network	-0.5% of total income realized in the business year for which the fee is paid; -the advance for periodic annual fee for the first year is 25,000.00 dinars per each 100 subscribers, on annual level
4)	Cable network services for	-0.2% of total income realized in the business

	distribution of radio and television programs, and for the provision of other telecommunications services, if wireless access is used	year for which the fee is paid; -the advance for periodic annual fee for the first year is 30,000.00 dinars per each 500 subscribers, on annual level
5)	Paging service	-0.1% of total income realized in the business year for which the fee is paid; -the advance for periodic annual fee for the first year is 10,000.00 dinars per each 1000 subscribers, on annual level
6)	Internet services, if own wireless access infrastructure is used	-0.1% of total income realized in the business year for which the fee is paid; -the advance for periodic annual fee for the first year is 50,000.00 dinars per each 1000 subscribers, on annual level
7)	Other services using numbers from the Numbering Plan	-0.1% of total income realized in the business year for which the fee is paid; -the advance for periodic annual fee for the first year is 50,000.00 dinars, on annual level

Article 3

The amount of the authorization fee is determined according to the type of telecommunication network and services and the amounts are as follows:

No.	Type of telecommunication network and service	Amount of authorization fee
1)	Access network	-0.1% of total income realized in the business year for which the fee is paid, and not less than 50,000.00 dinars
2)	Transport network	-0.1% of total income realized in the business year for which the fee is paid, and not less than 50,000.00 dinars
3)	Internet service provision	-0.1% of total income realized in the business year for which the fee is paid, and not less than 50,000.00 dinars
4)	IP telephony service provision, if the assignment of numbers from the numbering plan is not required	-0.1% of total income realized in the business year for which the fee is paid, and not less than 50,000.00 dinars
5)	Cable network service provision	-0.1% of total income realized in the business year for which the fee is paid, and not less than 100,000.00 dinars
6)	Data transmission service provision	-0.1% of total income realized in the business year for which the fee is paid, and not less than 50,000.00 dinars

7)	Value added service provision	-0.1% of total income realized in the business year for which the fee is paid, and not less than 50,000.00 dinars
8)	Service provision within closed group of users	-0.1% of total income realized in the business year for which the fee is paid, and not less than 50,000.00 dinars
9)	Call back service provision	-0.1% of total income realized in the business year for which the fee is paid, and not less than 50,000.00 dinars

Article 4

The total income means realized income, i.e. accrued income from performing the telecommunication activity for which the license, i.e. authorization is issued, in the business year for which the amount of fee is determined, deducted for the amount paid for interconnection, leased lines and other network resources to the license or authorization holders, stated in accordance with regulations governing accounting and auditing and the telecommunication sector.

Article 5

The costs of license issuance include the once-off amount payable for processing of license issuance application, purchase of tender documentation in the public bidding procedure and license issuance.

The amount payable for processing of license issuance application is 25,000.00 dinars.

The amount payable for the purchase of tender documentation is 0.01% of the smallest (initial) amount of the once-off fee, established in the public bidding procedure.

The costs of license issuance referred to in Article 2 of these Rules is 0.01% of the final amount of the once-off fee achieved in the public bidding procedure, deducted for the amount paid in accordance with paragraph 3 of this Article.

The costs of license issuance, pursuant to Article 106, paragraph 2 of the Telecommunications Law (*Official Gazette of the Republic of Serbia* number 44/03 and 36/06) is 0.01% of the established amount of the periodic annual fee.

Article 6

The costs of application issuance include the amount payable for processing of authorization issuance application and for entering the register of authorizations.

The costs of processing of authorization issuance application amount to 10,000.00 dinars.

The costs of entering the register of authorizations amount to 20% of the minimum fee set in Article 3 of these Rules.

Article 7

The costs of issuance of a duplicate of license or authorization amount to 50% of the costs set in Articles 5 and 6 of these Rules.

Article 8

The costs of the Republic Telecommunication Agency incurred by the procedure of license or authorization transfer equal the costs for processing of license issuance application, or costs for processing of authorization issuance application.

Article 9

These Rules, upon the Government approval, shall be published in the *Official Gazette of the Republic of Serbia* and shall come into force on the eight day following the day of its publication.
