

Pursuant to paragraph 2 of Article 19 and in regard to paragraph 11 of Article 86 of the Telecommunications Law (*Official Gazette of the Republic of Serbia* number 44/03 and 36/06) and pursuant to item 11 of Article 18 of the Statutes of the Republic Telecommunication Agency (*Official Gazette of the Republic of Serbia* number 78/05), the Managing Board of the Republic Telecommunication Agency, in its session held on 17th March 2006, adopted

RULES

ON COSTS OF TECHNICAL PERMITS – CERTIFICATE ISSUANCE AND OF TECHNICAL INSPECTION OF RADIO STATIONS, TELECOMMUNICATIONS NETWORKS, SYSTEMS AND FACILITIES

1. Contents

Article 1

These Rules determine the amount of costs of technical permits – certificates issuance and of performing technical inspection of radio stations and telecommunications networks, systems and facilities.

2. The amount of costs of technical permits – certificates issuance

Article 2

The amount of costs of the issuance of technical permits – certificates of compliance of the project and project documents with set standards and norms for telecommunications networks, systems and facilities shall be determined in relation to the investment value of telecommunications networks, systems and facilities in the project and project documents, and shall amount to:

The investment value of telecommunications networks, systems and facilities	Costs of technical permits – certificates issuance
under 5 million dinars	10,000.00 dinars
from 5 to 50 million dinars	25,000.00 dinars
from 50 to 200 million dinars	50,000.00 dinars
over 200 million dinars	80,000.00 dinars

Article 3

The amount of costs of the issuance of technical permits – certificates of compliance of building and installing of telecommunications networks, systems and facilities with

prescribed standards and norms, amounts to 10% of the costs referred to in Article 2 of these Rules.

Article 4

The amount of costs of the issuance of technical permits – certificates of compliance with prescribed standards and norms, in order to put telecommunications systems and facilities into operation amounts to:

For simple systems and facilities, based on passive components	10,000.00 dinars
For medium-complexity systems and facilities, which include passive and active components	25,000.00 dinars
For high-complexity systems and facilities, which include passive and active components and software	50,000.00 dinars

3. The amount of costs of technical inspection of radio station

Article 5

The amount of costs of technical inspection of radio station is determined in relation to the class of radio station and amounts to:

4. The amount of costs of technical inspection of telecommunications networks, systems and facilities

Article 6

The amount of costs of technical inspection of telecommunications networks, systems and facilities is defined in relation to investment value of telecommunications networks, systems and facilities in the project and project documents, and amounts to:

Investment value of telecommunications networks, systems or facilities	Costs of technical inspection of telecommunications networks, systems and facilities
Up to 5 million dinars	72,000.00 dinars
5-20 million dinars	100,000.00 dinars
20-50 million dinars	150,000.00 dinars
50-100 million dinars	180,000.00 dinars
100-150 million dinars	220,000.00 dinars
150-200 million dinars	250,000.00 dinars
over 200 million dinars	300,000.00 dinars

Article 7

For the issuance of a duplicate of the technical permit-certificate and of a duplicate of the report on radio station technical inspection or report on technical inspection of telecommunications networks, systems and facilities, 50% of the amount of costs set in these Rules shall be paid.

Article 8

These Rules, upon the Government approval, shall be published in the *Official Gazette of the Republic of Serbia* and shall come into force on the eight day following the day of the publication.
