

Pursuant to paragraphs 5 and 10 of Article 86 of the Telecommunications Law (*Official Gazette of the Republic of Serbia* number 44/03) and pursuant to item 11 of Article 18 of the Statutes of the Republic Telecommunication Agency (*Official Gazette of the Republic of Serbia* number 78/05), the Managing Board of the Republic Telecommunication Agency in its session held on 17th March 2006, adopted

RULES

ON TECHNICAL PERMITS – CERTIFICATES ISSUANCE

1. PRELIMINARY PROVISIONS

Article 1

These Rules define the mode of issuance, types and contents of technical permits – certificates.

Article 2

Technical permit – certificate is issued upon the request of a legal or natural person, who is projecting, building or operating public telecommunication network and/or providing telecommunication services, or person who puts telecommunication systems and facilities into circulation, after the procedure of control of compliance of telecommunication networks, systems and facilities with prescribed standards and regulations has been performed.

Article 3

In addition to request, the submitter of request from paragraph 1 of this Article submits to the Republic Telecommunication Agency (hereinafter: the Agency) complete documentation depending on type of technical permit – certificate.

The submitted documentation shall be in accordance with the Telecommunications Law, these Rules and other regulations applied by the Agency.

Article 4

In case all necessary documentation have not been submitted, the Agency shall give the submitter a period of 15 days in which the deficiency shall be remedied.

If the submitter does not submit the required documentation, referred to in paragraph 3 of Article 3 of these Rules, to the Agency in the established period, the Agency shall turn down the request for the issuance of technical permit – certificate, as incomplete.

In case the submitted documentation is not compliant with the regulations, and the deficiency is such that it can not be removed, the Agency shall turn down the submitter's request as unfounded.

Article 5

Technical permit – certificate shall be signed by the Chairman of the Managing Board of the Agency or by a person authorized by the Chairman, no later than 15 days after the procedure stipulated in the Rules on procedure for determining the compliance has been carried out.

Costs of issuance of technical permits – certificates are payable for the issued technical permits – certificates, according to the pricelist adopted by the Agency.

2. TYPES OF TECHNICAL PERMITS – CERTIFICATES

Article 6

The Agency issues the following technical permits – certificates of compliance with the prescribed standards and regulations:

- 1) project and project documentation for telecommunications networks and systems;
- 2) technical characteristics of telecommunications networks, systems and facilities;
- 3) building and installing of telecommunications networks, systems and facilities;
- 4) for putting in circulation telecommunication systems and facilities.

3. CONTENTS OF TECHNICAL PERMIT – CERTIFICATE

3.1. Technical permit – certificate of compliance of project and project documentation with prescribed standards and regulations for telecommunication networks and facilities.

Article 7

Technical permit – certificate of compliance of the project and project documentation with prescribed standards and regulations for telecommunication networks and systems is issued by the Agency on the basis of submitted request and appropriate documentation, after the procedure of compliance has been performed.

Along with the request and the project documentation, the submitter submits the following:

- 1) name, address, head office, Fiscal ID number and personal ID number of the submitter of request;
- 2) abstract from the register of business entities;
- 3) statement of acceptance of costs of the technical permit – certificate issuance;
- 4) three copies of the project, together with proof (verification) that it is made by responsible project designer, where one copy thereof remains in the Agency;
- 5) list of standards and regulations used in projecting of telecommunications networks and systems;
- 6) proof that project and project documentation are in compliance with standards and regulations stated by the submitter;
- 7) proof of payment of the established fee for the issuance of technical permit – certificate into the account of the Agency;

Article 8

Technical permit – certificate of compliance of project and project documentation with prescribed standards and regulations for telecommunication networks and systems shall be issued on the Agency letterhead and shall contain the following:

- 1) date and number of the issuance of technical permit – certificate;
- 2) legal basis for the issuance of technical permit – certificate;
- 3) name, address, Fiscal ID number and Personal ID number of the submitter of request with the submission date;
- 4) project name, designation and version, date of project registration, name of project organization;
- 5) decision whereby the technical permit – certificate is issued, stating standards and regulations, and the issuance thereof;
- 6) terms and conditions of the validity of the technical permit – certificate;
- 7) right to appeal.

3.2. Technical permit – certificate on compliance of the technical characteristics of telecommunication networks, systems and facilities with the prescribed standards and regulations

Article 9

Technical permit – certificate on compliance of the technical characteristics of telecommunication networks, systems and facilities with the prescribed standards and regulations is issued by the Agency on the basis of submitted request.

Along with the request, the submitter of request shall submit the following:

- 1) name, address, head office, Fiscal ID number and Personal ID number of the submitter of request;
- 2) a copy of registration with the Serbian Business Register Agency;
- 3) statement of acceptance of the costs of the technical permit – certificate issuance;
- 4) name and type of telecommunication network, system and facilities which are the subject of the technical permit – certificate issuance;
- 5) decision from the supplier on the compliance, in accordance with JUS ISO/IEC 17050-1/2005 standard;
- 6) supporting documentation in accordance with JUS ISO/IEC 17050-2/2005 standards;
- 7) proof of payment of the set fee into the Agency account.

Article 10

Technical permit – certificate on compliance of the technical characteristics of telecommunication networks, systems and facilities with the prescribed standards and regulations shall be issued on the Agency letterhead and shall contain the following:

- 1) date and number of the issuance of technical permit – certificate;
- 2) legal basis for the issuance of technical permit – certificate;
- 3) name, address, Fiscal ID number and Personal ID number of the submitter of request with the submission date;
- 4) name, designation, series of the networks, systems and facilities;
- 5) decision whereby the technical permit – certificate is issued, stating standards and regulations, and the issuance thereof;
- 6) terms and conditions of the validity of the technical permit – certificate;
- 7) right to appeal.

3.3. Technical permit – certificate on compliance of the building and installing of telecommunication networks, systems and facilities with the prescribed standards and regulations

Article 11

Technical permit – certificate on compliance of the building and installing of telecommunication networks, systems and facilities is issued by the Agency on the basis of the submitted request.

Along with the request, the submitter of request shall submit the following:

- 1) name, address, head office, Fiscal ID number and Personal ID number of the submitter of request;
- 2) a copy of registration with the Serbian Business Register Agency;
- 3) statement of acceptance of the costs of the technical permit – certificate issuance;
- 4) statement stating the designation and date of issuance of the technical permits – certificates by the Agency;
- 5) proof confirming that the submitter of request has procured all necessary certificates and approvals from the competent authorities in accordance with the regulations, and that it will hire licensed – authorized building constructors.
- 6) statement from the submitter of request that when building and installing the telecommunication network, system and facilities, they will provide protection of private property, safety and protection of people's health, and ensure safe traffic flow and environment protection, especially regarding radiation which is considered harmful under the governing standards.
- 7) proof of payment of the set fee into the Agency account.

Article 12

Technical permit – certificate on compliance of the building and installing of telecommunication networks, systems and facilities with the prescribed standards and regulations shall be issued on the Agency letterhead and shall contain the following:

- 1) date and number of the issuance of technical permit – certificate;
- 2) legal basis for the issuance of technical permit – certificate;
- 3) name, address, Fiscal ID number and Personal ID number of the submitter of request with the submission date;

- 4) name, designation, series, location and time of building of the telecommunication network, system or facilities;
- 5) a list of documentation and previous permits submitted by the submitter of request;
- 6) decision whereby the technical permit – certificate is issued, stating standards and regulations, and the issuance thereof;
- 7) terms and conditions of the validity of the technical permit – certificate;
- 8) right to appeal.

3.4. Technical permit – certificate on compliance with the prescribed standards and regulations for putting telecommunication systems and facilities in operation

Article 13

Technical permit – certificate on compliance with the prescribed standards and regulations for putting telecommunication systems and facilities in operation is issued by the Agency on the basis of the submitted request.

Along with the request, the submitter of request shall submit the following:

- 1) name, address, head office, Fiscal ID number and Personal ID number of the submitter of request;
- 2) a copy of registration with the Serbian Business Register Agency;
- 3) statement of acceptance of the costs of the technical permit – certificate issuance;
- 4) name, designation, series of the system or facility for which the permit is requested;
- 5) statement stating designation and date of issuance of the technical permit – certificate on the compliance with technical characteristics of telecommunication system and facilities issued by the Agency;
- 6) supporting documentation for customers;
- 7) proof of payment of the set fee for the issuance of technical permit – certificate into the Agency account.

Article 14

Technical permit – certificate on compliance with the prescribed standards and regulations for putting telecommunication systems and facilities in operation shall be issued on the Agency letterhead and shall contain the following:

- 1) date and number of the issuance of technical permit – certificate;
- 2) legal basis for the issuance of technical permit – certificate;
- 3) name, address, Fiscal ID number and Personal ID number of the submitter of request with the submission date;
- 4) decision whereby the technical permit – certificate is issued, stating the technical permit – certificate referred to in item 2) of Article 6 of these Rules;
- 5) name, designation, series of the system or facility for which the permit is requested;
- 6) right to appeal.

4. FINAL PROVISION

Article 15

The forms for technical permits – certificates defined in these Rules are printed with these Rules and are the integral part thereof.

Article 16

These Rules come into force on the eighth day following the day of the publishing in the “Official Gazette of the Republic of Serbia”.
