

ISSUANCE OF APPROVAL FOR IMPORT OF GOODS

In accordance with Article 86 of the Law on Telecommunications (*Official Gazette of the Republic of Serbia* no. 44/2003) and the Decision on determining the goods of which import, export and commerce are subject to special conditions (*Official Gazette of the Republic of Serbia* no. 114/2005), the Republic Telecommunication Agency issues approvals for import of goods classified under the following tariff designations:

Request for the issuance of approval for import of goods shall be submitted to the **Republic Telecommunication Agency, Belgrade, Plamotićeva 2.**

Following should be specified in the request:

1. tariff designation;
2. name and type of telecommunication device for which the approval for import is requested;
3. end-user of telecommunication device;

Documents to be attached:

1. technical documentation that shows whether the characteristics of the telecommunication device for which the approval for import is requested (such as frequency, power, etc.) comply with the Radio Frequency Band Allocation Plan (*Official Gazette of the Republic of Serbia* no. 112/04), which is also available on the RTA website, under: Regulations – Bylaws;
2. certificates relative to electromagnetic compatibility, protection of human health and environment, CE certificate, and similar;

General documents to be attached:

1. a copy of Decision on Registration of the company – importer, issued by the Agency for Business Registration or by the Commercial Court;
2. a copy of Record of Deposited Signature (OP form);
3. a copy of Certificate of VAT Registration;
4. a copy of Certificate of PIB Registration.

The fee for processing of request and issuance of approval is regulated by a Contract between the contractual parties: 1. the Republic Telecommunication Agency, on the one hand, and 2. the applicant submitting the request for the issuance of approval for import of goods, on the other. The amount pertinent to the fee (CSD 5 000 per request and CSD 2 000 per item of the request) should be paid by the applicant into current account of the **Republic Telecommunication Agency no. 840-963627-41, reference number 600-40 and aim of payment order: fee for processing of request and issuance of approval.**

On received evidence of payment of the above stated amount, the Republic Telecommunication Agency shall issue the approval for import of goods.

The approval for import of goods shall be issued no later than 10 (ten) days from the day the request for approval of import of goods is submitted.

The approval is valid for one year from the day of the issuance. The number of shipments during the validity of approval is unlimited.
