Pursuant to Article 8, paragraph 1, item 5a) and Article 23, paragraph 1 of the Law on Electronic Communications (Official Gazette of RS 44/10, 60/13 -CC, 62/14 and 95/18 - other law), Article 6 paragraph 3 item 1) and Article 29 of the Law on Postal Services ("Official Gazette of RS", no. 77/19), Article 12 paragraph 1 items 1) and 6) and Article 16 paragraph 1 items 4) and 5) of the Statute of the Regulatory Agency for Electronic Communications and Postal Services ("Official Gazette of RS", no. 125/14 and 30/16), Management Board of the Regulatory Agency for Electronic Communications and Postal Services, at the 51st session of the third convocation, held on July 24, 2020, issued the following

RULEBOOK

on establishing uniform tariff positions for universal postal service

Article 1

This Rulebook establishes uniform tariff positions according to the weight rate of postal items and types of postal services in the field of universal postal service.

The uniform positions listed in paragraph 1 of this Article shall be printed with this Rulebook and shall form its integral part.

Article 2

The largest weight for postal items from the field of universal postal service in national postal traffic is determined by the law regulating postal services in the Republic of Serbia.

The highest marked value and dimensions of postal items from the area of the universal postal service in national postal traffic are determined by the provider of the universal postal service.

Article 3

The maximum weight for postal items in international postal traffic is determined, as a rule, by the acts of the Universal Postal Union.

The highest marked value and dimensions of postal items from the field of universal postal service in international postal traffic are determined by the universal postal service provider, in accordance with the acts of the Universal Postal Union or on the basis of bilateral agreements of postal operators appointed by the member states of the Universal Postal Union.

Article 4

Handling of postal items, services at the request of the user and services ex officio, which can be performed during the provision of postal services in the field of universal postal service, are an integral part of the uniform tariff items from Article 1 of this Rulebook.

Article 5

On the date of entry into force of this Rulebook, the Rulebook on Determining Tariff Rates for the Universal Postal Service ("Official Gazette of RS", no. 34/10, 58/10, 2/11, 65/11, 21/14, 83/16 and 14/18) ceases to be valid.

Article 6

This Rulebook shall come into effect on the eighth day of its publication in the Official Gazette of the Republic of Serbia".
