


Virtuous cycle of the digital economy

Ambitious "Key Performance Broadband Targets" of Digital Agenda

Basic broadband for all by **2013**: basic broadband coverage for **100**% of EU citizens.

(Baseline: Total DSL coverage (as % of the total EU population) was at 93% in December 2008.)

Fast broadband by **2020**:

broadband coverage at 30 Mbps or more for 100% of EU citizens.


(Baseline: 23% of broadband subscriptions were with at least 10 Mbps in January 2010.)

Ultra-fast broadband by 2020:

50% of European households should have subscriptions above **100Mbps**. (No Baseline)




The European Digital Agenda Governance Cycle
